PARTICIPANT WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT

IMPORTANT: This waiver must be agreed to by each participant or their parent/legal guardian. By registering, participating, or checking the agreement box below, each participant (or parent/guardian for minors) agrees to these terms:

1. ASSUMPTION OF RISK

Each participant understands that participation in this walking event involves inherent risks including but not limited to: physical injury, property damage, illness, weather-related hazards, traffic, uneven surfaces, crowded conditions, and other unforeseen circumstances. Each participant voluntarily assumes all risks associated with participation in this Event.

2. RELEASE AND WAIVER OF LIABILITY

Each participant (and parent/guardian for minors) hereby releases, waives, discharges and covenants not to bring any legal claims against Şiyyôn, its organizers, sponsors, volunteers, staff, affiliates, and all associated parties (collectively "Released Parties") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury that may be sustained during or in connection with this Event.

3. FOOD AND REFRESHMENTS

Each participant understands that food, beverages and refreshments may be provided during the Event. Each participant acknowledges that the Released Parties make no warranties regarding the safety, quality, or suitability of any food or beverages provided. Each participant assumes all risk related to consumption of any food or beverages and releases the Released Parties from any claims related to food allergies, food-borne illness, or adverse reactions.

4. MEDICAL CONDITIONS AND FITNESS

Each participant (or parent/guardian for minors) affirms that the participant is in good physical condition and has no medical conditions that would prevent safe participation in this walking event. It is each participant's responsibility to consult with a physician if there are any health concerns before participating.

5. PHOTOGRAPHY AND MEDIA CONSENT

Each participant (or parent/guardian for minors) grants permission to Şiyyôn and its authorized representatives to photograph, film, and/or record the participant during the Event. Each participant consents to the use of such images, videos, and recordings for promotional, educational, and ministry purposes including but not limited to websites, social media, publications, and marketing materials, without compensation or further consent.

6. CHRIST-CENTERED NATURE OF EVENT

Each participant understands this is a faith-based, Christ-centered event organized for spiritual purposes including prayer, worship, and Christian fellowship. By participating, each participant acknowledges and respects the religious nature of this gathering.

7. INDEMNIFICATION

Each participant (or parent/guardian for minors) agrees to indemnify and hold harmless the Released Parties from any loss or liability incurred as a result of the participant's participation, including any claims brought by third parties.

8. GOVERNING LAW

This agreement shall be governed by the laws of Jamaica. Any legal proceedings must be brought in the appropriate courts of Jamaica.

9. SEVERABILITY

If any provision of this waiver is deemed invalid, the remaining provisions shall remain in full force and effect.

11. EVENT CHANGES AND CANCELLATION

The Released Parties reserve the right to modify event details, route, timing, or cancel the event due to weather, safety concerns, or other circumstances beyond their control. No refunds will be provided for any reason including event modification or cancellation. Participants acknowledge that their registration fees and purchases constitute donations to support the ministry.

12. BINDING AGREEMENT

For Adult Participants (18+): By registering, participating, or having someone register you, you personally agree to all terms of this waiver. Your participation in the event constitutes acceptance of these terms even if registered by another person.

For Minor Participants (Under 18): The parent or legal guardian completing registration or providing consent certifies they have full legal authority to bind their minor child to this agreement and assume all responsibilities outlined herein.

Group Registrations: If one person is registering multiple participants, that person confirms that all adult participants will be bound by these terms through their participation in the event, and that they have parental/guardian authority for any minors registered.
